I, Surabhi Mahnot, Company Secretary and Compliance Officer of the Company hereby certify that the Paid up Equity Share capital of the Company is Rs. 1,00,00,000/- and the net worth of the company is Rs. 4,50,38,000/- as on 31.03.2022. As per Regulation 15(2) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the compliance with the corporate governance provisions as specified in regulations 17 to 27 and clauses (b) to (i) of sub-regulation (2) of regulation 46 and paras C, D and E of Schedule V of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 shall not apply, in respect of:
