I, Surabhi Mahnot, Company Secretary and Compliance Officer of the Company hereby certify that the Paid-up Equity Share capital of the Company is Rs. 1,00,00,000/- and the net worth of the company is Rs. 4,52,31,277/- as on 31.03.2023.
